### **SCOPE**

4. Help to provide placement assistance to the final year students and arrange campus interviews.
5. Conduct joint venture programs for members of MADITSSIA and others using resources available at the institute.
6. Conduct workshops and seminars both for the students and faculty of the institute to appraise the various technological advancement taken place in the present industrial scenario and

### **OBJECTIVES**

By working together for the mutual benefits, it is aimed that the following objectives can be fulfilled, thus making the technical education more purposeful and meaningful.

1. Work together in such a way that this partnership will be a role model to other institutes and industrial associations to follow.
2. Help mutually to grow in content, updating, management and skill training to enable the industries to concentrate on production and leave training to institutes.
3. Train necessary human resources both in industries and institute so that the updating programs can be made cost effective
4. Develop rapport between industries and institute to enable the institute to generate quality outputs and tailor made personnel for industry requirements.

### **TERMS OF REFERENCE**

The Madurai District Tiny and Small Scale Industries Association(MADITSSIA) hereinafter called the ASSOCIATION and the S.I.T Pulloor, Kariapatty hereinafter called the INSTITUTION will arrange and offer training programs in the areas identified by both INSTITUTION and ASSOCIATION to the members of ASSOCIATION, faculty



and students of the INSTITUTION and other public and provide placement and other assistance and will enter into a MEMORANDUM OF UNDERSTANDING signed by the elected body of the ASSOCIATION and by the Chairman of the INSTITUTION with a written understanding with respect to identification of areas in which training to be given, identification of industries which provide placement, organizing, controlling and monitoring of various training programs and general policies developed as and when necessary for other activities, budgeting, accounting and sharing of proceeds in case of joint venture program and sustainability of the venture on a long term basis.

Detailed terms of reference for this committee will be formulated in a joint sitting. This committee will at least meet once in three months to discuss the various aspects of the areas identified. The constitution of the Steering Committee is as follows:

The steering committee meeting will be held at S.I.T or in the City office at Madurai and MADITSSIA premises, Madurai alternately. The Secretary will convene the meeting and inform the members as and when required. The secretary will prepare the agenda of the meeting and one member will record the minutes of the meeting.

### **PROGRAMME DEVELOPMENT**

The INSTITUTION will collect the list of industries discipline wise from the ASSOCIATION, which are ready to provide industrial training to students and staff and send them for training during semester holidays.

The members of the association will take part in the conference, seminars and workshops conducted by the Institution for exchange of information. The staff and students of the Institution will also take part in the conference, seminars and workshops conducted by the association.

The INSTITUTION will arrange industrial visit to the students and staff in selected industries of the ASSOCIATION and nearby medium and large-scale industries with the help of the ASSOCIATION.

The INSTITUTION will take necessary steps to conduct training program for the industrial personal in the areas identified by the industries by considering the resources and expertise available in the INSTITUTION. The steering committee will decide and take decisions in this regard.

The INSTITUTION and the ASSOCIATION shall periodically assess the needs and draw plans for the offering various joint venture programs to the outsiders also. The course may be delivered at the institute or outside.

To provide placement services to the students, the institute will contact the office bearers of the association and collect the placement opportunities from them. They will be requested to visit the institute to recruit the students. The institute will send data bank of eligible students every year to the office of the ASSOCIATION so as to contact them whenever necessary.

#### BUDGET AND OTHER FINANCIAL COMMITMENTS

There will be no financial or accommodation commitment to the association for the in-plant training and industrial visits of students.

The expenditure incurred for the conduct of the workshops, seminars and conferences for the students of the institute will be borne by the institute.

Conveyance and hospitality for industrial personnel coming for the campus interview to recruit students will be provided by the institute.

A nominal amount will be charged by the institute from the industrial personnel to meet out the training cost of the programs conducted by the institute to industrial personnel. This will be decided by the steering committee.

For each joint venture program to the outsiders, a detailed budget will be prepared and this will be approved by steering committee. Should there be any deviation in the budget, from the actual expenditure this should be placed before steering committee for ratification. A statement of Expenditure & Income in request of programs conducted shall be placed before the steering committee once in three months for approval and the sharing of proceeds is to take place only after the entire realization and settlement of bills of each program. Should there be any deficits in a program, it is borne by the Association/Institute, which conducts that program. The accounts for the program will be subjected to ratification by the steering committee as and which necessary.



## COMPENSATION



(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

#### WHEREAS:

- A) First Party is a Higher Educational Institution named:
  - I. **Sethu Institute of technology**
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) – **Kani Vilas Technology Services** – , the Second Party is engaged in Business, Manufacturing, Skill Development, Education and R&D Services in the fields of - **SKILL DEVELOPMENT, OUTCOME BASED TRAININGS, PLACEMENT, R&D SERVICES AND RELATED SERVICES** - and related fields

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:



## CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. - 2.6 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- 2.7 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.8 **Placement of Trained Students:** Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships/jobs; and will facilitate placements for at least 75% of the students. The Second Party will itself absorb at least 75 percentage of the trained students.
