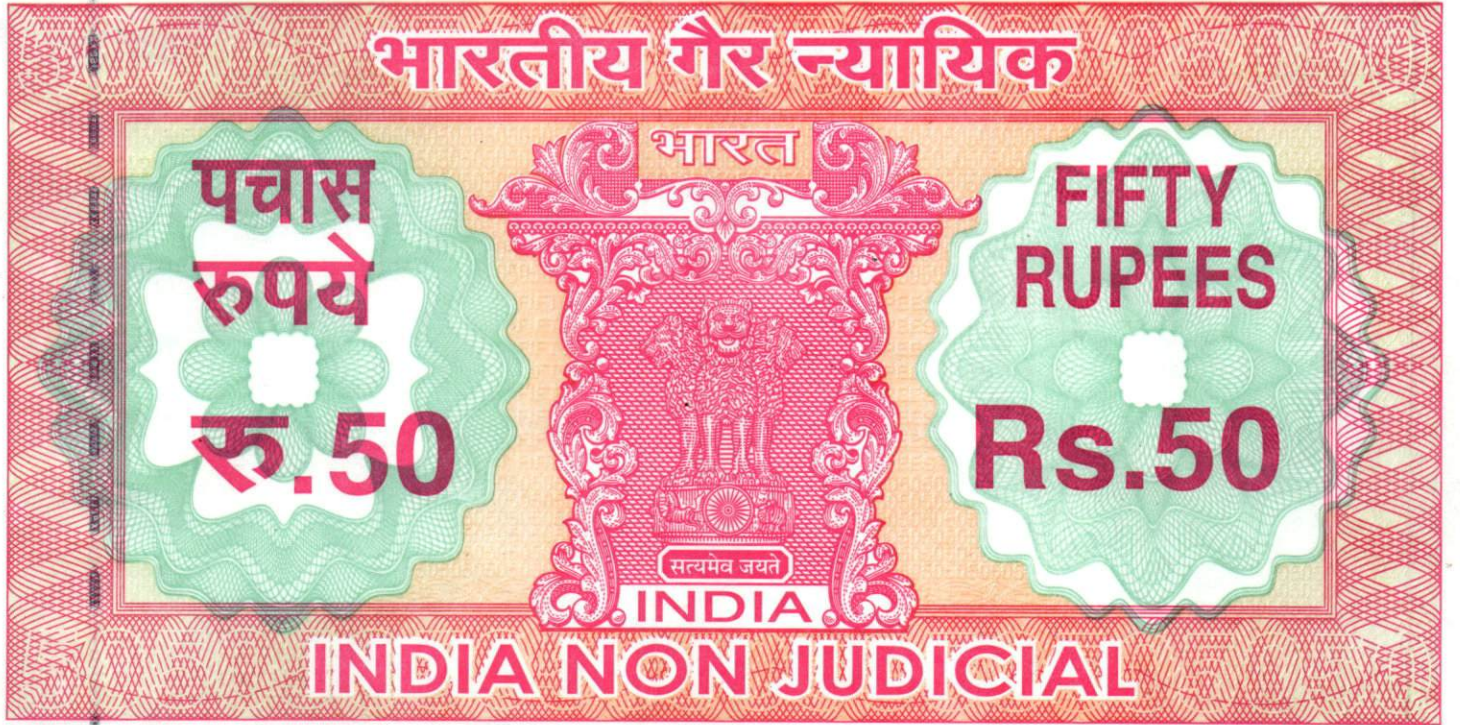



### M-KUBE CONTRACTORS, Madurai Shall Provide

- The Incubation Center in the size of 20'-0" X 20'-0" for locating M-KUBE CONTRACTORS office inside the college campus.





- The incubation centre should encompass of Five number of computer systems and other required stationaries like white board, markers.
- The Schedule with the classes for the training program
- The supports to ensure all students who have signed to attend the Internship programs scheduled for them.
- The relevant software installed in the computer systems.
- Disciplinary support for the smooth conduct and timely completion of the entire course.
- Minimum One Year to Two Years of Internship Training time.
- At the time Onsite Training, Sethu Institute of Technology has to provide a minimum of 2000 Sqft of land, which may vary depending upon students strength for practicing of site activities.
- Provide all support to M-KUBE CONTRACTORS in the marketing initiatives undertaken by M-KUBE CONTRACTORS to enroll students in Onsite Training program and internship offered by M-KUBE CONTRACTORS. Sethu Institute of Technology will provide all infrastructural facilities for the marketing initiatives undertaken by M-KUBE CONTRACTORS.

#### **INTERNS:**

The participants would be the Students of *Sethu Institute of Technology* from Civil Engineering stream from 5<sup>th</sup> to the 8<sup>th</sup> Semesters .

#### **INTERNSHIP AND WORKSHOPS:**

M-KUBE CONTRACTORS in consultation with *Sethu Institute of Technology* shall finalize the Internship programs with stipend and Onsite Program with fees for the skills development of students. These will be reviewed every year and suitable changes, if required, will be incorporated. As the requirement of each course is different, courses and fees have been worked out separately for each branch.

#### **INTERNSHIP**

The Internship Program will conducted during the days and timings provided by M-KUBE CONTRACTORS. The Intern will be selected, according to their theoretical and practical sound through interview and training program. #### **ONSITE TRAINING PROGRAM**

**VALIDITY**



This Memorandum of Understanding will be valid for a period of **4** years.




#### **VALIDITY**





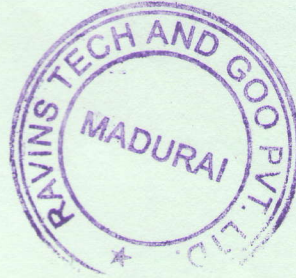
