The following were discussed:-

1. The Principal briefed about the prevention of ragging the student's community, particularly, first year students in our college premises. He insisted to articulate ragging prevention acts to the students.

2. It has been decided to provide assistance through professional counselor to counsel 'freshers' in order to prepare them for the life ahead, particularly for adjusting to the life in hostels.
3. It was decided to have an Anti ragging help line phone number and disseminate it to each and every student as well as to be pasted on the walls.
4. It was decided to divide the first year students into small groups and each group shall be assigned to a faculty member. The faculty member should interact individually with each student of the group on daily basis to discuss the problems/difficulties.
5. The measures to be taken to prevent ragging and steps to be taken to identify the offenders were discussed.
6. It was decided to have separate wings for the 1<sup>st</sup> year and 2<sup>nd</sup> year hostellers and no seniors should be allowed to enter their wings without permission.
7. It was recommended to rusticate those who are involved in ragging.
8. It was suggested to have anti-Ragging Placards all over the campus.
9. The details of Anti-ragging affidavit obtained from the students and parents were informed to the members of the committee.
10. The principal concluded the meeting by insisting to have ragging free campus and thanked the members for their participation.
